# **NEW! South Lake Education Center Summer Camp**



This year, with the restoration of the Poultney Nature Trail behind its office at the South Lake Education Center in Poultney, PMNRCD is able to offer a one week place-based camp at the South Lake Education Center and Nature Trail for children ages 7 – 10.

Children participating in this camp will explore their surroundings using science/ scientific method and the arts together to facilitate an integrated learning experience. The summer camp is made possible through Lake Champlain Basin Program and will be offered through the Poultney Recreation Department. #### **Agriculture**

PMNRCD serves the local agricultural community by providing free technical assistance, farm equipment rentals, and other programs to benefit the farming community. PMNRCD is constantly evolving to provide better service to our agricultural community. We regularly partner with UVM Extension, Vermont Agency of Agriculture, Vermont Agency of Natural Resources, and USDA/NRCS to provide an expanded knowledge base and cost share opportunities.

#### Agronomy and Conservation Assistance Program (ACAP)

Priority is given to farms that are not subject to permitting under the state medium- or large-farm operation programs.





### **Regional Conservation Partnership Program (RCPP)**

PMNRCD, in partnership with the Vermont Association of Conservation Districts (VACD), University of Vermont Extension and VT Natural Resource Conservation Service (NRCS) is assisting small farm operators in the development of nutrient management plans (NMPs).

## **Agricultural Equipment Use/Rental**

**New!** No-Till Drill: Thanks to the generosity of the Lookout Foundation, PMNRCD has purchased a 10ft Haybuster 107C No-Till Drill. The unit has 2 large seed boxes and a separate legume/small seed, seed box. Seeding space is 7.5in and the working width is 10ft. This unit is available for free to farmers until fall 2017.

**Also** available for rental is the **8'9" Gen-TillAerator**. Aerators create a vertical slit in the soil that opens up the soil for better water and nutrient infiltration and decreases compaction at the surface, at least on a temporary basis.

### Portable Skidder Bridge

PMNRCD had our first skidder bridge built this year for use on timber harvesting operations. The Forestry and Natural Resources Program at Stafford Technical Center built the bridge at their location in Rutland. It was then trucked to Northeast Timber Exchange where it is available for monthly rental.

Portable Skidder Bridges allow loggers to harvest timber while following the "Acceptable Management Practices for Maintaining Water Quality on Logging Jobs in Vermont" (AMPs). This portable skidder bridge was made possible through an Ecosystem Restoration Program grant to the Vermont Association of Conservation Districts and with assistance from the Vermont Department of Forests, Parks and Recreation. ## **Champlain Valley Native Plant Restoration Nursery**



The nursery is a partnership between the Poultney-Mettowee Conservation District , The Nature Conservancy, and Green Mountain College. The main goal of the nursery is to the propagation of native seeds for plantings for stabilizing streambanks, restoring native plant communities, re-establishing connectivity of habitat along riparian corridors, improving water quality, and preventing the spread of non-native plant material in the landscape.

Many volunteer and internship opportunities exist for individuals and groups interested in learning about native plant production including seed collection, propagation and growing operations. ### Lake Education and Action Program (LEAP)

LEAP is a collaborative community outreach, education, and ACTION program also made possible through Watershed Alliance. The purpose of LEAP is to increase local awareness of lake water quality issues by planting substantial buffers and rain gardens around Lake St. Catherine for individual homeowners. LEAP is sponsored by **Lake Champlain Sea Grant**, a marine and great lakes initiative coordinated through NOAA (National Oceanic and Atmospheric Administration).

# **Water Quality Initiatives**

#### **Trees for Streams**

PMNRCD receives grant funding to plant buffers for landowners who have bodies of water on or adjoining their land. These vegetative buffers will increase available wildlife cover and food supply, improve aquatic habitat and food supply, protect water quality, increase connectivity of wild lands, as well as reduce erosion and flooding damage. *Trees for Streams* is a state-wide program funded by an Agency of Natural Resources (ANR) Ecosystem Restoration Program (ERP) grant through the Vermont Association of Conservation Districts.
