Watershed Projects

"Thinking as a watershed" is a model PMNRCD works to instill. Having this view in mind helps to build awareness of the interconnected nature of the natural and social communities within the working landscape. The Districts work with towns on streambank erosion, infiltration opportunities, and infrastructure needs while also working to protect species and habitat diversity. Additionally, PMNRCD works with the South Lake watershed community to develop greater understanding of weather and climate impacts within the landscape and to develop greater resiliency in storm events.

Stormwater Projects:

The District helps area towns, businesses, and landowners understand and implement green stormwater projects. These projects use techniques that incorporate natural water cycle principles into urban water drainage systems for improved water quality in nearby streams and water bodies and help protect against flooding and erosion. Green stormwater projects include those that increase the infiltration of stormwater at the source, such as capturing water from impervious roofs or paved areas and infiltrating it into a nearby rain garden or a larger, engineered bio-infiltration area.
